



Portugal includes two metropolitan areas — Lisbon and Oporto – which together represent only 5% of continental territory and where 43% of the population lives


Metropolitan systems are the ones who can best characterize the coastal area, namely, as:




NATIONAL OCEAN STRATEGY GOVERNANCE MODEL FOR PARTNERSHIP AGREEMENT – PORTUGAL 2020
